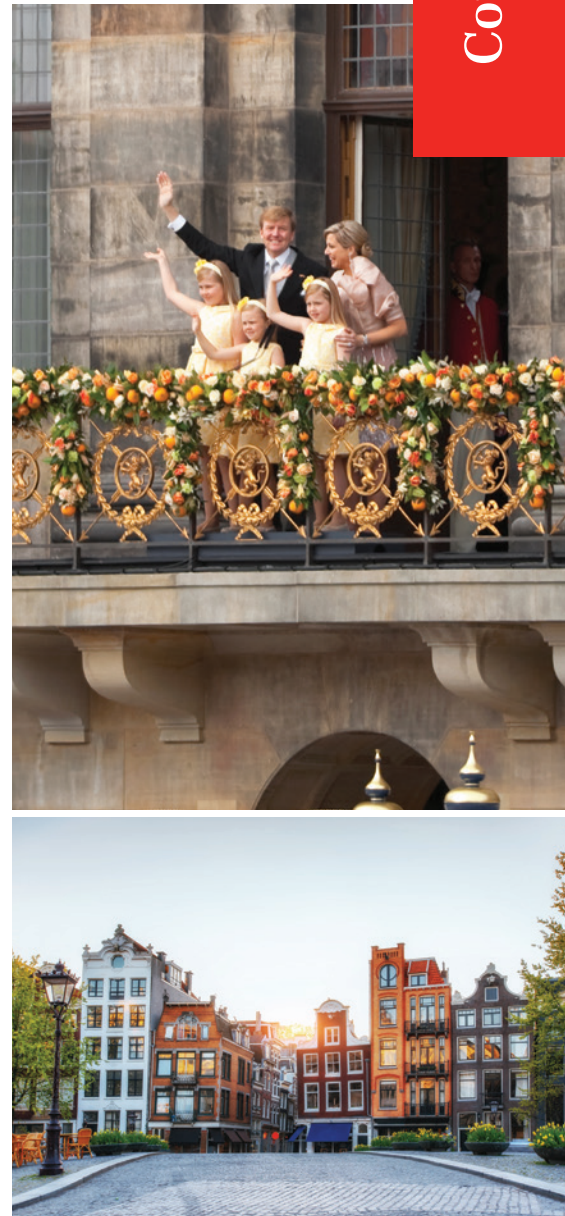


The Netherlands – attractive business destination

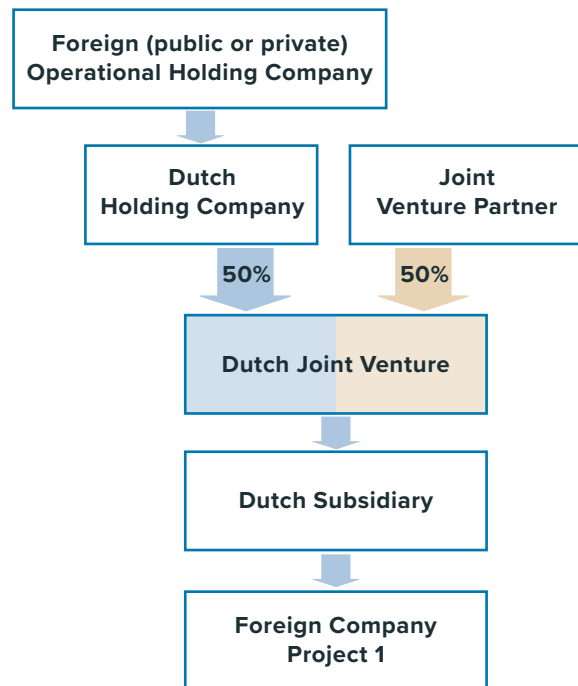

Why is this important?

Proper structuring provides for tax optimization, the latter being one of the primary determining factors especially on the level of large corporates, though, being also important for mid-size or small businesses.

Effective corporate structuring also plays the leading role in the framework of necessity to comply with the BEPS legislation (“Base Erosion and Profit Shifting”), which was not long ago adopted by the OECD. High level of conformity with the requirements of laws is the key to success for modern business!

It is well known that opening a corporate bank account nowadays is not an easy task, successful accomplishment of this task being mostly dependent upon a company complying with the requirements of the laws. Only structures with high level of compliance being kept internally on a constant basis, following all the regulations and good practices, is eligible for passing the KYC (“Know your client”) procedure.

FAQ

Does a Dutch company need to have a pre-paid share capital?

This was the case in the past, but this requirement is no longer in place. A BV should have a minimum share capital of € 1 and there is no timeline as to the date of payment.

How long does it take to register a company in the Netherlands?

A company in the Netherlands may be registered in course of 1 week.

How much does it cost to register a company in the Netherlands?

The cost of registering a company in the Netherlands depends on the complexity of the incorporated structure and is estimated on an individual basis. A regular structure set up costs start from € 3 000 (before VAT), including notarial expenses.

Is personal presence of shareholders required by registration procedures in the Netherlands?

It is not obligatory for the shareholders to be personally present before the Notary in the Netherlands to register a company. A notary may sign a deed of incorporation acting on the basis of a legalized proxy, issued by the shareholders.

Is information about shareholders and directors of a Dutch company available to the public?

In case a Dutch company has a sole shareholder, information about the latter is published and can be seen from an extract requested from the Chamber of Commerce. In case a Dutch company has two or more shareholders, information about the shareholders is not published.

Information on directors of a Dutch company is registered with the Chamber of Commerce.

Is it obligatory for a Dutch company to have a corporate bank account with a Dutch bank?

It is not obligatory for a company registered in the Netherlands to have a corporate bank account opened with a bank in the Netherlands. A Dutch company is free to have a corporate bank account (-s) with any bank in any jurisdiction upon its own discretion. An important criteria a company should meet in order to be recognized as a Dutch tax resident – is to perform operations through the corporate bank account (-s) from the territory of the Netherlands.
